A. **Discussion, Consideration, and Possible Action by Board of Investigations and Complaints. Pursuant to A.R.S. § 38-431.03(A)(2), the Board may go into executive session for discussion and consideration of confidential information.**

(1) Dr. Carol Eastman, Case No. 08-025 – Investigative Interview

Dr. Eastman was present, along with her Attorney Mr. Holt. Mr. Holt made statements and answered questions. After discussion and consideration by the Board, Mr. Micuda made a motion to move the case forward to Formal Interview. Second by Dr. Sadilek. After further discussion by the Board, Mr. Micuda amended his motion to include giving staff the ability to negotiate a consent agreement. Second by Ms. Barron. Motion carried 7 Ayes.

(2) Dr. Alan Christianson, Case No(s) 08-018, 08-021, 08-036, and 08-038 – Investigative Interview

Case No. 08-021 was presented first. Dr. Christianson was present. Dr. Christianson made statements and answered questions. After discussion and consideration by the Board, Mr. Micuda made a motion to dismiss the case and issue a Letter of Concern to Dr. Christianson. Second by Dr. Rubin. Motion carried 7 Ayes.

Second by Dr. Waldman. Dr. Rubin; Aye, Ms. Barron; Nay, Mr. Micuda; Nay, Dr. Sadilek; Nay, Dr. Walker; Aye. Motion carried 4Ayes, 3 Nays.

Case No. 08-036. Dr. Christianson made statements and answered questions. After discussion and consideration by the Board, Mr. Zang made a motion to move the case to Formal Interview. There was no second to the motion. Dr. Rubin made an alternative motion to dismiss the case. Second by Mr Micuda. Dr. Walker: Nay. Motion carried 6 Ayes, 1 Nay

Case No. 08-038 Dr. Christianson made statements and answered questions. After discussion and consideration by the Board, Dr. Waldman made a motion to move the case to Formal Interview. Second by Dr. Rubin. Ms Barron abstained. Motion carried 6 Ayes 1 Abstained.

(3) Dr. Shannon Maltais, Case No. 08-032, Investigative Interview

Dr. Maltais was present, made statements and answered questions. After discussion and consideration by the Board, Dr. Barron made a motion to dismiss the complaint. Second by Mr. Zang. Motion carried 7 Ayes.

(4) Dr. Kelly Hannigan, Case No. 08-027 – Formal Interview

Dr. Hannigan was present, made statements and answered questions Dr. Rubin made a motion to place the case on administrative hold until such time Kelly Hannigan is licensed by the Board. Second by Dr. Waldman. Motion carried 7 Ayes.

(5) Dr. Donald Mayfield, Case No. 08-024, Case No. 08-037, and Application for Medical License Renewal. Item 4 A (5) was taken into consideration by the Board after 4 A (9).

Dr. Mayfield was present, made statements and answered questions.

Dr. Waldman made a motion to go into Executive Session for legal advice. Second by Ms Barron. Motion carried 7 Ayes.

The Board resumed regular session at 4:10 pm.

Mr. Micuda made a motion to rescind the Board order bringing both cases to Formal Hearing, without prejudice and reserve entertaining the matters in the context of licensure renewal. Second by Dr. Waldman. Motion carried 7 Ayes.

Dr. Rubin made a motion to go into Executive Session for legal advice. Second by Mr. Zang. Motion carried 7 Ayes.

The Board resumed regular session at 4:15 pm.

Ms. Barron made a motion to go into Executive Session for legal advice. Second by Mr. Zang. Motion carried 7 Ayes.

The Board resumed regular session at 4:17 pm.

After discussion and consideration by the Board, Mr. Micuda made a motion “to approve the renewal of the license for Dr. Mayfield, without prejudice to the two complaints we have right now which I move that they go to Formal Interview”. Second by Dr. Waldman. Motion carried 7 Ayes.

(6) Dr. Hanna Ian, Case No. 07-011 – Non compliance with Board order; Consideration of Proposed Consent Agreement.

Dr. Walker Recused herself. After discussion and consideration by the Board, Mr. Micuda made a motion to approve the consent agreement. Second by Ms. Barron. Roll Call: Ms. Barron; Aye, Dr. Sadilek; Aye, Mr. Micuda; Aye, Mr. Zang; Aye, Dr. Waldman; Aye, Dr. Rubin; Aye. 6 Ayes, 1 Recused.

A 5 minute recess was called at 3:00 pm.

(8) Dr. Jennifer Burns, Case No. 08-029, Investigative Interview

Dr. Burns was present, made statements and answered questions. After discussion and consideration by the Board, Mr. Micuda made a motion to continue both cases 08-029 and 08-024 and bring back to the Board upon completion of further investigation. Second by Mr. Zang. Motion carried 7 Ayes. Mr. Micuda amended his motion to continue only case no. 08-029 and to consider case 08-042 at this time. Second by Ms. Barron. Motion carried 7 Ayes.

(9) Dr. Jennifer Burns, Case No. 08-042, Investigative Interview

Dr Burns made statements and answered questions. After discussion and consideration by the Board Mr. Micuda made a motion to move the case forward to Formal Interview. Second by Ms. Barron. Motion carried 7 Ayes
